Kids Are Kids! Facebook Guidelines

The Marketing and Fundraising Sub-Committee has established an Official Kids Are Kids! Facebook Group that it will use to share information of interest to the families of Kids Are Kids!, the wider community and its corporate and individual supporters.

Membership of the Facebook Group to read and post information is at the sole discretion of the Marketing and Fundraising Sub-Committee so that it can maintain the privacy and integrity of information and the good reputation of Kids Are Kids!.

The group is not a closed group, however all content posts by users will be reviewed and approved by Administration before being made public on the page .

The Purpose of the Kids Are Kids! Facebook Group

The group has been created in an effort to bring families and supporters of children with learning delays or disabilities together. Kids Are Kids! will promote services, programs and events to Members through the group to raise awareness of those services and events and in turn provide more help to more families and benefiting the organisation's business. The group, in collaboration with parties involved will also share success stories of a child's therapy outcomes to be testament to the dedication that the staff at Kids Are Kids! gives to children and their families. The group will be used for associated industry organisations and associations to post events suitable to our audience, to be an additional resource to families.

Membership is granted on the condition that the member will abide by Facebook's conditions of use as well as the following Marketing and Fundraising Sub-Committee's acting for Kids Are Kids! conditions of use:

- A member must be over the age of 13 to comply with the Facebook conditions of use
- Kids Are Kids! has the right to report any member under the age of 13 being a member of the Kids Are Kids! Facebook page and their account may be cancelled immediately
- The Group is operated by the Kids Are Kids! Marketing and Fundraising Sub-Committee as part of its support of Kids Are Kids! and is inclusive of the Management and Staff of Kids Are Kids!
- A request to join the Group is taken as consent to agree with these conditions of use
- Members must only post information that seeks to advance the spirit of raising the potential of children within the community
- Any posts are to be approved by the Administrator before being published
- The content of the Group is at the sole discretion of the Administrator who may remove or edit any post for any reason
- The posting of personal information including photographs must be done with the consent of the parent or guardian or person concerned
- The Administrator will assume that any member posting personal information about another person or child has obtained the necessary consents until informed otherwise

- Any person may ask to have theirs or their child's personal information including photographs removed from the Group and it will be immediately done so by the Administrator
- Any personal detail including names and/or photographs will be posted by Kids Are Kids! Administration only after written consent is supplied following request
- Any complaint about a decision by the Administrator shall be made at first instance to the Administrator and all parties will seek a resolution in the best interests of the Kids Are Kids! community
- The page will not be used to exchange medical advice for individual situations
- If the Administrator cannot resolve the complaint then the person is to email their complaint to the CEO who shall be the final decision maker on resolution
- The CEO may direct the Administrator to edit or remove any material on the Group at his/her sole discretion
- The CEO may direct the Administrator to close the Group at any time if he/she, at his/ her sole discretion, believes that it is in the best interests of Kids Are Kids! to do so
